## 61/23 Planning Applications

AVA/2023/0282 Infil single storey flat roof extension Turners Cottage, 2 Leys Houses, Bell Lane No objections

AVA/2023/0325 variation of condition 1 to allow the existing flat roof on a barn conversion to be replaced with a pitched roof to provide two first floor bedrooms.

Object as this is an over development of the site, out of character with the surrounding area and the planning application has previously been rejected.
